**Wednesday:** Free continental breakfast at hotel. Ski Holiday Valley and depart for home at 4:30pm

- **West Side Pick Up:** Bus loads at 5:45 am and leaves at 5:55 am from Lenau Park; 7370 Columbia Rd., Olmsted Falls (about 1 mile north of Bagley)
- **East Side Pick Up:** Bus loads at 6:20 am and leaves 6:30 am from Holiday Inn; 780 Beta Dr, Mayfield Village 44143; Take the Wilson Mills Exit on I-271. Beta Drive is just east of I-271 on the NORTH side of Wilson Mills Road. Look for the sign for the Holiday Inn.
- **Far East Side Pick Up:** at I - 90 and Rt. 534. North of 90 on west side of 534 behind the Best Friends Restaurant. Let the trip leader know if you want this stop.
- Return about 9:00 p.m. Wednesday
