Trip Application & Agreement Form for Steamboat Jan. 31 to Feb. 7, 2012

This trip is sponsored by SUBURBAN SKI CLUB (SSC). Each individual registering for this trip must complete the form below. A person who is not a member of a club affiliated with CMSC must pay a membership fee and submit a membership application along with this form.

1. Deposits and Payments: The required deposit for this trip is \$ 300.00 and must be paid and submitted along with this signed Application and Agreement Form. The first payment of \$300 is due by September 15; the second payment of \$333 is due by October 15; the third payment of \$333 is due by November 15; and the last payment is \$333 and due by December 15, 2011. Make checks payable to Suburban Ski Club and mail to Robin Spooner; Suburban Ski Club; 6245 Dewey Road; Madison, Ohio 44057.

2. Withdrawal and Change: The Clubs may refuse to accept or retain any person as a participant at any time for any reason; and may change the itinerary at any time. The trip price is based upon a minimum of 32 skiers and may be canceled if there are less than 32 paid skiers.

3. Responsibility: The Clubs are acting gratuitously for the applicant and shall not be responsible or liable for any loss of or damage to baggage, property, or for any loss, injury, death, accident, delay, inconvenience or any other loss occurring during or occasioned by applicant's participation in this Steamboat trip, and as a result of any actual or alleged negligence of SSC or any ski club member or officer.

4. Minors: Any minor's Application & Agreement must be co-signed by his/her parent or legal guardian. The minor must be accompanied on the trip by a parent or legal guardian or their designee who shall be wholly and fully responsible for said minor's conduct and well being.

5. Cancellation & Refunds:

A) Cancellation by participant means and includes: failure to abide by the terms of this agreement, notice by participant of intent to cancel; participant's failure to make timely payments; participant's failure for any reason to meet the departure or return times of the trip.

B) Where SSC cancels or withdraws this trip, the participant shall be entitled to a full refund unless such cancellation or withdrawal is necessitated or caused, in whole or part, by participant's cancellation or failure to make timely payments.

C) Where participant cancels on or before November 1, 2011, participant shall be responsible for a cancellation service charge of not less than \$25.00.

D) In addition, where participant cancels after November 1, 2011 and where the trip departs full (32 or more skiers) or where participant provides an immediate replacement who completes this agreement, then participant shall receive a full refund less the cancellation service charge. However, if the trip departs less than full and participant has not provided a replacement, then participant may be entitled only to a refund taking into account any amounts paid by SSC for participant's unused transportation, lodging, meals, lifts, or amenities and less the cancellation service charge. The amount of the refund, if any, is at the sole discretion of SSC.

6. Eligibility: Participation in this trip is available to members of ski clubs associated with Cleveland Metro Ski Council. Those who are not members of such a club must fill out a SSC membership application and pay the membership fee
