Jay Peak, with a vertical of 2,153 feet, is located in northern Vermont a few miles from the Canadian border. It has been known for its unbelievable terrain, incomparable glades, and abundant natural snowfall. (The most snow in eastern North America averaging 355" per year). Vermont's only aerial tramway is one of 8 lifts accessing 385 acres of terrain, including 76 trails and, new this season, 4 terrain parks for skiers and riders of all abilities. Jay Peak's boundary-to-boundary woods policy makes it a favorite among advanced skiers and riders but the glades aren't for experts only. Trip Application & Agreement for Jay Peak December 13 to 19, 2009
Sponsored by Suburban, Hi Rise, and Other Participating Ski Clubs hereinafter know as "The Clubs"

The undersigned participant applies to participate in the Jay Peak trip described below, subject to the following terms and conditions:

1. **Deposits and Payments:** The required deposit for this trip is \$ 350.00, and must be paid and submitted along with a signed Application and Agreement by October 31, 2009. The balance shall be due and payable on or before November 30, 2009. Make checks payable to Suburban Ski Club and mail to Jack Ganz, Suburban Ski Club, 3211 Chadbourne Road, Shaker Heights, Ohio 44120.
2. **Withdrawal and Change:** The Clubs may refuse to accept or retain any person as a participant at any time for any reason; and may change the itinerary at any time. The trip price is based upon a minimum of 21 skiers and will be canceled if there are less than 21 paid skiers.
3. **Responsibility:** The Clubs are acting gratuitously for the applicant and shall not be responsible or liable for any loss of or damage to baggage, property, or for any loss, injury, death, accident, delay, inconvenience or any other loss occurring during or occasioned by applicant's participation in this Jay Peak trip, and as a result of any actual or alleged negligence of Clubs or any ski club member or officer.
4. **Minors:** Any minor's Application & Agreement must be co-signed by his/her parent or legal guardian. The minor must be accompanied on the trip by a parent or legal guardian or their designee who shall be wholly and fully responsible for said minor's conduct and well being.
5. **Cancellation & Refunds:**
 - A) Cancellation by participant means and includes: failure to abide by the terms of this agreement, notice by participant of intent to cancel; participant's failure to make timely payments; participant's failure for any reason to meet the departure or return times of the trip.
 - B) Where The Clubs cancel or withdraw this trip, the participant shall be entitled to a full refund unless such cancellation or withdrawal is necessitated or caused, in whole or part, by participant's cancellation or failure to make timely payments.
 - C) Where participant cancels on or before October 15, 2009, participant shall be responsible for a cancellation service charge of not less than \$25.00.
 - D) In addition, where participant cancels after October 15, 2009 and where the trip departs full (21 or more skiers) or where participant provides an immediate replacement who completes this agreement, then participant shall receive a full refund less the cancellation service charge. However, if the trip departs less than full and participant has not provided a replacement, then participant may be entitled only to a refund taking into account any amounts paid by The Clubs for participant's unused transportation, lodging, meals, lifts, or amenities and less the cancellation service charge. The amount of the refund, if any, is at the sole discretion of The Clubs.
7. **Eligibility:** Participation in this trip is available to members of ski clubs associated with Cleveland Metro Ski Council, their family and their guests.
