A MESSAGE FROM THE PRESIDENT



Dear Suburban Ski Club Members,

Our Trips and Tours Committee has been busy planning another spectacular ski season for you. We are still finalizing a couple of details, but I can tell you that a trip to Mammoth Mountain in California in late January will almost certainly be on our schedule as well as a return trip to Sunday River, Maine the last week of February. As you will read below, we are still reviewing options for a third major trip in late March.

In early May, about twenty of our major-trip skiers and members of our Executive Board met at my house to talk about skiing in 2020. I want to thank all of them for attending and offering their ideas. We took a close look at Telluride, Big Sky, Jackson Hole, Mammoth and Breckenridge. We all agreed that, while we have members who can handle Jackson Hole, it would be preferable to opt for a resort that offers a wider selection for all ski levels. With that in mind, we decided to focus on Telluride, Big Sky and Mammoth. Of the three, Mammoth provided us with the best value, including slope-side lodging for a reasonable price. Telluride and Big Sky would also have been great, but we found that the cost of airfare drove pricing to well over \$2,000. For that reason, we decided to go back to the drawing board to look at March options.

We are open to suggestions for this third major trip. Two tour operators are looking at Snowbird/Alta in Utah and Whitefish in Montana for starters. Feel free to email me if there is another area you think we should consider.

For the two settled major trips (Mammoth and Sunday River), we should have flyers and registration forms ready later this month and, as a club member, you will have first dibs on signing up before we post our trips on the Cleveland Metropolitan Ski Council website. I suggest you sign up early to ensure yourself a place.

Thanks go to **Mary Ellen** and **Ed Noss** for organizing our EAT at the Rocky River Wine Bar on Tuesday, May 21st. Although we were disappointed the patio was not open due to the weather, the more than twenty diners who attended had a wonderful evening.

Be sure to look up at the Calendar of Events later in this newsletter (and the attachments) for details on **Ann McBrian's** annual picnic and concert at **Blossom on Sunday, July 7**. Peter and Paul from Peter, Paul & Mary will join the Cleveland Orchestra for what should be a memorable and nostalgic concert.

Tuesday, June 4 @ 9:00 AM: Hike at The West Woods

This hike and a second one are being billed as “Hiking with Larry and Almuth.” That would be SSC members, **Larry Grewe** and **Almuth Riggs**. For this first one, we will meet Larry and Almuth at the **West Woods Nature Center** at **9:00 AM**. The address is 9465 Kinsman Rd; Russel Twp. 44072

This 902-acre park protects the historic sandstone ledges of Ansel’s Cave, Silver Creek and its watershed and has extensive wetlands and mature forests. The West Woods Nature Center is a popular attraction with its large wildlife feeding area and hands-on interpretive displays. There are nine trails which total 6.95 miles. On this morning we plan to hike the Ansel's Cave and Pioneer Bridle Trails. The total hike will be about 4 1/2 miles. Anyone can shorten (or add to) their hike based on their time, interest or fitness.

Saturday, June 8 @ 10:00 AM: Do the LaDue

Melinda Kellerstrass says “It’s time to paddle!” Canoe, Kayak or go with Melinda’s favorite Stand Up Paddleboard on this Saturday at the LaDue South Reservoir.. We will meet at **10:00 AM** in the parking lot on Rt 44 about 1 mile south of Rt 422, just before you cross the bridge. (We will be paddling under that bridge!).

You can bring your own equipment or rent. If you need to rent, there is a company that services LaDue. Find them at in at: <https://www.breakawayexcursions.com> Be aware, that you do need to go online and reserve in advance. Make sure to follow the prompts and book for **Sat, June 8 at 10:00 AM at LaDue South** . You also need to fill out the release forms etc. They do not handle cash sales so everything needs to be done on line, in advance. I recommend booking early. They do sell out on weekends.

LaDue is one of my favorite places to paddle. If you have not been there, you are in for a treat. They only allow electric motors, so it is a peaceful lake. Contact me if you have questions: Melinda@suburbanskiclub.org. I will be there unless it is raining or the wind is above 10 mph.

It will be a special evening of nostalgia as Peter and Paul remember the late Mary Travers and their enduring anthems of social change and the impact they had on the world of civil liberties.

Although the concert begins at 7:00 PM, we will be gathering any time after 4:30 PM for our pre-concert picnic in the area called the **Lawn Terrace** (located at the top of the hill and centered above the pavilion). Ann will be taking orders for a barbeque buffet provided by City Barbeque and/or salads prepared by Panera Bread. Please see the [Order Form](#) for details.

Attached is an ORDER FORM to place your order for lawn tickets and your meal. But you should feel free to bring your own picnic if you wish. Beverages are not provided and you may bring your beverage of choice.

Also please note that the Order Form is attached in two versions. Those of you who have access to Excel spreadsheet software, can use that version to fill out your order form. Others can print out the PDF version. Mail the form and payment to Ann McBrian at the address on the attached page of GENERAL INFORMATION. If you are ordering food for more than one person, be sure to follow the online directions.

Parking is free with tram service provided to get you to the main gate. Ann advises you come early to beat the traffic and parking rush.

A single lawn ticket price for the evening is \$22.60. But Ann is hoping to buy books of lawn tickets at a savings of \$5.10 per ticket. Provided we are able to purchase the books, refunds on the tickets will be given the night of the concert. Should you not want to sit on the lawn, lawn tickets are also valid for general admission seating in the pavilion. Your tickets will be held in your name at the “Will Call” window.
